- **e.** Backup generators for power outages Discussed what is needed to install and wire generators. We did not receive the Power Resiliency Grant, will look for more grants.

- **d.** Pursue Calfire inspections on homes in community Not enough personnel due to their being busy inspecting homes for sale as homes cannot be sold without Calfire inspection.

- f. Information on clearing lots Will continue to pursue avenues to enforce clearing.
